## **LOBBYING ACTIVITIES**

In 2017, the Company's federal lobbying expenses totaled approximately \$1,900,000.00. This amount includes employee time and travel associated with lobbying activity, payments to external consultants and lobbyists, and trade association dues used for lobbying.
